**AMENDMENT NO. 1
TO THE INTERCONNECTION, COLLOCATION AND RESALE AGREEMENT FOR THE STATE OF
MISSOURI
BETWEEN
TELEPORT COMMUNICATIONS GROUP INC. AND EMBARQ MISSOURI, INC.**

Amendment No. 1 made this 10th day of September, 2009, is entered into by and between Teleport Communications Group Inc. ("CLEC") and Embarq Missouri, Inc. ("Embarq"). Embarq and CLEC are collectively referred herein as the "Parties".

BACKGROUND:

WHEREAS, the Parties entered into an Interconnection, Collocation and Resale Agreement for the state of Missouri ("Agreement") on July 9, 2009.

WHEREAS, the Parties wish to amend the Agreement to reflect the legal entity name change for CLEC.

In consideration of the promises and agreements contained in this Amendment, the Parties hereby agree as follows:

AMENDMENT:

1. The Agreement contains the former legal entity name of Teleport Communications Group Inc. This Amendment replaces the former legal entity name for CLEC with the new legal entity names of TCG Kansas City, Inc. and TCG St. Louis.
2. Except as modified herein, the terms and conditions of the Parties July 9, 2009, Interconnection, Collocation and Resale Agreement shall continue in full force and effect.
3. This Amendment No. 1 is executed by authorized representatives of Embarq and CLEC is made a part of and incorporates the terms and conditions of the July 9, 2009, Interconnection, Collocation and Resale Agreement.

IN WITNESS WHEREOF, Embarq and CLEC has caused this Amendment No. 1 to be executed by its duly authorized representatives.
