INTERCONNECTION AND RECIPROCAL COMPENSATION AGREEMENT

This Interconnection and Reciprocal Compensation Agreement ("Agreement"), dated March 19, 2010, is entered into by between Telecom North America Mobile, Inc., ("CLEC"), and Spectra Communications Group, LLC, ("CenturyLink") to establish the rates, terms and conditions for local interconnection and reciprocal compensation for the state of Missouri. CenturyLink and CLEC may be referred to individually as a "Party" and collectively as the "Parties".

NOW THEREFORE, the Parties agree as follows:

1. INTERCONNECTION AND RECIPROCAL COMPENSATION AGREEMENT

The Parties agree that the Agreement between the Parties shall consist of the Interconnection and Reciprocal Compensation Agreement between Spectra Communications Group, LLC and WWC License LLC dated February 20, 2003 (the "Adopted Agreement").

All services provided under this Agreement will be consistent with the decisions of courts having jurisdiction over this Agreement, including but not limited to the decisions of the Court of Appeals and the United States Supreme Court.

2. PARTIES:

CLEC is hereby substituted in the Adopted Agreement for WWC License LLC and CenturyLink shall remain as the other Party to the Adopted Agreement. Except as modified herein, the Agreement shall in all other respects reflect the same terms as the Adopted Agreement.

3. TERM:

The effective date of this Agreement is March 19, 2010. This Agreement shall have an initial term of one year.

4. NOTICES:

Except as otherwise provided, all notices and other communication hereunder shall be deemed to have been duly given when made in writing and delivered in person or deposited in the United States mail, certified mail, postage paid, return receipt requested and addressed as follows:


