NOTICE CANCELING PREHEARING CONFERENCE

COMES NOW Southwestern Bell Telephone, L.P., d/b/a Southwestern Bell Telephone Company ("SWBT"), and for its Notice Canceling Prehearing Conference, states as follows:

1. On May 24, 2002, the Missouri Public Service Commission ("Commission") issued its Order Setting Prehearing Conference. In that Order, the Commission noted that "there appears to be a disagreement regarding the proposed interconnection agreement. The Commission finds that a prehearing conference should be scheduled to address the matter." The Commission scheduled the prehearing conference for June 5, 2002.
2. MCImetro Access Transmission Services, L.L.C., Brooks Fiber Communications of Missouri, Inc., MCIWorldCom Communications, Inc. and SWBT have resolved all outstanding disputes between the parties.
3. Based on the parties' assurances that all outstanding disputes have been resolved, Judge Ruth agreed to cancel the prehearing conference scheduled for June 5, 2002, and requested that the parties file a pleading so stating.

WHEREFORE, Southwestern Bell Telephone, L.P., d/b/a Southwestern Bell Telephone Company, prays the Commission accept its Notice Canceling Prehearing Conference.
