

**MOTION TO POSTPONE PRE-HEARING CONFERENCE**


Comes now Choctaw Telephone Company and moves that the May 22, 3003 Prehearing Conference Ordered on May 19, 2003 be postponed indefinitely or continued generally. In support of this Motion Choctaw states the following:

1. Staff filed a recommendation expressing concerns about certain section of the interconnection agreement submitted for approval.
2. Subsequently the parties have agreed to amend the interconnection agreement to delete the sections concerning Staff. Today at a conference call Staff indicated this amendment will resolve its concerns. The parties will execute the amendment, and file it in the case as soon as possible.
3. It is not possible that the amendment will be executed and filed before the May 22 prehearing conference.
4. Choctaw believes that the filing of the amendment will be successful in resolving the concerns or issues raised by Staff, and the Commission's consideration of the interconnection agreement can proceed without the necessity of a prehearing conference or procedural schedule. No entity has intervened or filed opposition to the agreement submitted for approval.

5. Sprint Spectrum L.P. and Staff are aware of this Motion to Postpone Pre-hearing Conference and do not oppose it.

WHEREFORE, Choctaw requests that the Commission postpone the Pre-hearing Conference indefinitely.
