**SECOND ERRATA AND JOINT MOTION
TO MODIFY ORDER APPROVING INTERCONNECTION AGREEMENT**

Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC Missouri"), and MCImetro Access Transmission Services, LLC ("MCI") respectfully file this second errata to correct the conformed compliance interconnection agreement ("ICA") between SBC Missouri and MCI that was filed with the Commission on August 9, 2005. It has been discovered that when the ICA was filed, the parties had inadvertently failed to include an Out-of-Exchange Traffic Appendix ("OE-LEC Appendix") therein. Attached hereto are (a) the OE-LEC Appendix, Bate-Stamped as pages 627-631, which the parties had agreed upon and thus had intended to file with the Commission (which is SBC Missouri's 13-State OE-LEC Appendix), and (b) a corrected page of the General Terms and Conditions, Bate-Stamped as page 6, which lists the OE-LEC Appendix as Appendix XXXIV within the table of contents and which should be substituted for the original page filed.

WHEREFORE, SBC Missouri and MCI respectfully request that the Commission accept this second errata as a necessary correction to the August 9, 2005 filing in the above-referenced case, and further, that the Commission modify its August 8, 2005,

Order Approving Arbitrated Interconnection Agreement to incorporate therein its approval of the August 9, 2005, filing as corrected by this second errata.


